## 2012

- August-December - The process participants are developing proposed resolutions to the public comments.

- July - The LEO-SCS-002 standard committee begins the process of reviewing the comments submitted during the public comment period.

- April - The LEO-SCS-002 draft standard is released for public comment by the American National Standards Institute (ANSI), with a comment period of April 6 to July 10, 2012.

- February - Standard Committee votes to approve the draft standard and Annex A for public comment.

- January - Updated versions of the main body of the standard, Annex A, and a Guide to Annex A were distributed to the committee for review.
